### PRODUCER PRICE INDICES IN INDUSTRY<sup>1,2</sup>, APRIL 2023

## 1. Total Producer Price Indices in Industry<sup>3</sup>

The Total Producer Price Index in Industry went down by 2.3% in April 2023 compared to the previous month. Lower prices were registered in the electricity, gas, steam and air conditioning supply by 8.3%, and in the manufacturing by 0.1%. The prices increased by 1.4% in the mining and quarrying industry.

In the manufacturing, the prices fell in the manufacture of chemicals and chemical products by 3.8%, in the manufacture of food products by 1.1%, in the manufacture of fabricated metal products, except machinery and equipment by 0.7%. Prices grew in the manufacture of leather and related products by 12.6%, in the manufacture of basic metals by 1.8%, in the manufacture of computer, electronic and optical products by 1.6%.

The Total Producer Price Index went down by 3.5% in April 2023 compared to the same month in 2022. Prices fell in the electricity, gas, steam and air conditioning supply by 19.0%, and in the mining and quarrying industry by 2.1%. Higher prices was seen in the manufacturing by 3.6%.

In the manufacturing, the most significant increase in prices was reported in the manufacture of tobacco products by 46.3%, in the manufacture of other non-metallic mineral products by 29.2%, in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials - by 18.4%. The prices decreased in the manufacture of basic metals by 11.3%.

<sup>&</sup>lt;sup>1</sup> Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered an early measure of the current inflation process in the economy and they can be used for international comparisons. Information for calculation of Producer Price Indices is received on the basis of monthly surveys on producer prices of industrial products sold on the domestic market and on industrial products sold on the non-domestic market. Producer price surveys are based on a constant sample of groups of products, and that sample is representative of total industrial production.




Figure 1. Total Producer Price Indices in Industry (2015 = 100)

#### 2. Producer Price Indices on Domestic Market<sup>1</sup>

The Producer Price Index on the Domestic Market fell by 3.2% in April 2023 compared to the previous month. The domestic prices went down in the electricity, gas, steam and air conditioning supply by 7.0%, and in the manufacturing by 0.8%. The prices raised in the mining and quarrying industry by 2.2%.

In manufacturing, compared to the previous month, prices went down in the manufacture of chemicals and chemical products by 5.5%, in the manufacture of electrical equipment by 1.1%, in the manufacture of basic metals by 0.7%, in the manufacture of food products by 0.6%. Prices increased in the manufacture of motor vehicles, trailers and semi-trailers by 1.9%, in the manufacture of other non-metallic mineral products by 1.4%, in the manufacture of tobacco products by 1.3%.

The Producer Price Index on the Domestic Market decreased by 4.7% compared to April 2022. Lower prices were reported in the electricity, gas, steam and air conditioning supply by 18.1%. An increase was observed in the manufacturing by 6.5%, and in the mining and quarrying industry by 1.1%.

In the manufacturing, compared to April 2022, a more compelling price increase was reported in the manufacture of tobacco products by 60.5%, in the manufacture of leather and related products by 37.9%, in the manufacture of other non-metallic mineral products by 26.5%, in the manufacture of wood and of products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials by 26.2%. The prices went down in the manufacture of basic metals by 17.0%, and in the manufacture of chemicals and chemical products by 7.9%.




Figure 2. Producer Price Indices on Domestic Market in Industry (2015 = 100)

#### 3. Producer Price Indices on Non-domestic Market<sup>1</sup>

The Producer Price Index on the Non-domestic Market decreased by 0.9% in April 2023 compared to the previous month, and by 1.5% compared to the same month of 2022.
