



# 1. Total Producer Price Indices in Industry

**The Total Producer Price Index in Industry** fell by 0.1% in April 2024 compared to the previous month. Lower prices were registered in the electricity, gas, steam and air conditioning supply - by 4.5%. An increase was observed in the mining and quarrying industry - by 6.1%, and in the manufacturing industry - by 0.9%.

In the manufacturing, the prices went up in the manufacture of basic metals - by 3.0%, in the manufacture of leather and related products - by 0.9%, and in the manufacture of rubber and plastic products - by 0.8%. A decrease was seen in the other manufacturing - by 2.4%, and in the manufacture of chemicals and chemical products - by 1.4%.

**The Total Producer Price Index** went down by 6.6% in April 2024 compared to the same month in 2023. There was a considerable decrease in prices in the electricity, gas, steam and air conditioning supply - by 28.3%. An increase was observed in the mining and quarrying industry - by 8.2%, and in the manufacturing industry - by 0.6%.

In the manufacturing, the most significant increase in prices was reported in the manufacture of computer, electronic and optical products - by 11.1%, in the manufacture of rubber and plastic products - by 10.0%, and in the repair and installation of machinery and equipment - by 9.6%. Considerable decrease was registered in the manufacture of leather and related products - by 9.9%, in the manufacture of wood and products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials - by 8.7%, and in the manufacture of paper and paper products - by 7.4%




Figure 1. Total Producer Price Indices in Industry

#### 2. Producer Price Indices on Domestic Market

**The Producer Price Index on the Domestic Market** decreased by 0.8% in April 2024 compared to March 2024. The domestic prices went down in the electricity, gas, steam and air conditioning supply - by 4.1%. An increase was observed in the mining and quarrying industry - by 4.9%, and in the manufacturing industry - by 0.4%.


In the manufacturing, compared to the previous month, higher prices were reported in the manufacture of motor vehicles, trailers and semi-trailers - by 2.1%, in the manufacture of rubber and plastic products - by 1.4%, and in the manufacture of basic metals - by 1.3%. A decrease was observed in the other manufacturing - by 3.5%, and in the manufacture of chemicals and chemical products - by 1.2%.

**The Producer Price Index on the Domestic Market** fell by 10.6% compared to April 2023. A drop was reported in the electricity, gas, steam and air conditioning supply - by 28.4%. An increase was observed in the mining and quarrying industry - by 2.8%, and in the manufacturing industry - by 0.1%.

Compared to April 2023, in the manufacturing higher prices were seen in the manufacture of motor vehicles, trailers and semi-trailers - by 9.0%, in the manufacture of wearing apparel and also in the repair and installation of machinery and equipment - both by 8.2%,

and in the manufacture of furniture - by 7.4%. A significant drop was registered in the manufacture of wood and products of wood and cork, except furniture; manufacture of articles of straw and plaiting materials - by 9.9%, in the manufacture of basic metals - by 8.8%, and in the manufacture of chemicals and chemical products - by 8.7%.

#### 3. Producer Price Indices on Non-domestic Market

The Producer Price Index on the Non-domestic Market increased by 1.1% in April 2024 compared to the previous month, and by 0.4% compared to the same month of 2023.

## Methodological notes

Producer Price Indices measure the average change in the prices of industrial products, which are produced and sold by Bulgarian enterprises. They can be considered an early measure of the current inflation process in the economy and they can be used for international comparisons. Information for the calculation of Producer Price Indices is received on the basis of monthly surveys on producer prices of industrial products sold on the domestic market and on industrial products sold on the non-domestic market. Producer price surveys are based on a constant sample of groups of products, and that sample is representative of total industrial production.

Total Producer Price Indices are calculated from Producer Price Indices on the Domestic Market and Producer Price Indices on the Non-domestic Market weighted with the turnover structure on the domestic and the non-domestic market to the total value of turnover in the base year (2015).

Producer Price Indices on the Domestic Market are calculated at a constant base (2015), weighed with the turnover structure on the domestic market.

Producer Price Indices on the Non-domestic Market are calculated at a constant base (2015), weighed with the turnover structure on the non-domestic market.
