

INDUSTRIAL PRODUCTS IN KIND

According to the preliminary data for 2008 there has been a significant **increase** in production of the following industrial products in comparison with 2007:

In Mining and Quarrying: common clays and shales for construction use - 82.2%, bentonite - 53.5%, slate - 34.4%, crushed stone of a kind used for concrete aggregates, for road metalling or for railway or other ballast - 27.3%, gypsum and anhydrite - 17.4%.

In Manufacturing: rail locomotives powered from an external source of electricity - 100.0%, unwrought unalloyed refined copper - 81.2%, invalid carriages motorized or mechanically propelled - 77.4%, spirits obtained from distilled grape wine or grape marc - 71.1%, graphic paper, paperboard - 69.7%, tomato juice - 69.4%, medicaments of other antibiotics, p.r.s. - 66.1%, readymixed concrete - 57.3%,semi-milled or wholly milled (bleached) rice - 56.2%, frozen fish fillets - 53.9% and others.

At the same time during 2008 manufacture of the following products has kept growth: tomato puree, fresh or chilled fish fillets and other fish meat without bones, mouldboard ploughs, DC motors and generators of an output > 0.75 kW and ≤ 7.5 kW, electric instantaneous water heaters, cereal flours (excluding wheat or meslin), yarn of carded wool or fine animal hair, n.p.r.s., frozen hams, shoulders and cuts with bone in, of pig meat, unconcentrated juices (excluding orange, grapefruit, pineapple, tomato, grape and apple juices), sulphuric acid, wine (excluding white wine) and others.

In 2008 as compared to 2007 a **decrease** has been registered in the production of the following industrial products:

In Mining and Quarrying: dolomite - 68.9%, precious metal ores and concentrates - 64.5%, granite, crude or roughly trimmed - 58.0%, fireclay - 36.8%, kaolin - 35.7%, chalk - 30.9%, kaolinitic clays - 16.7%, marble and travertine, crude or roughly trimmed - 13.0%, silica sands - 9.4%, construction sands -3.2% and others.

In Manufacturing: synthetic latex rubber - 73.6%, woven fabrics of cotton, for household linen - 61.1%, fresh or chilled whole turkeys - 56.7%, electricity supply or production meters - 34.8%, fresh or chilled whole geese, ducks and guinea fowls - 30.8% and others.

In 2008 a slowdown in the rates of decrease in production of the following products was seen: electric water heaters (excluding instantaneous), hydraulic lime, non-motorized bicycles, men's town footwear with leather uppers, oil paints and varnishes, vaccines for veterinary medicine, kaolin, bed linen of cotton (excluding knitted or crocheted), self-propelled fork-lift trucks powered by an electric motor, with a lifting height ≥1m, prefabricated structural components for building or civil engineering, of cement, concrete or artificial stone, margarine, refined sunflower-seed and safflower oil, slaked lime, white wine in specified regions, shampoos, toothpaste, non-refractory clay roofing tiles, fireclay and others.

In 2008 as compared to the previous year, the production of the following products continued to decrease: fresh or chilled whole geese, ducks and guinea fowls, syringes, with or without needles, unconcentrated juice of any single citrus fruit (excluding orange and grapefruit), yarn of combed wool or fine animal hair, n.p.r.s., washing preparations and cleaning preparations, with or without soap, n.p.r.s., electro-mechanical hand drills of all kinds, woven fabrics of cotton for clothing, toothpaste, liquid supply or production meters, shampoos, sacked lime, refined sunflower-seed and safflower oil, margarine and others.

For some manufactures the share of production on sub-contracting base reaches from 90% to 100%, for example: parts of piston engines, snow-ski footwear, electric motors of an output \leq 37.5 W, bed linen of nonwoven man-made fibers and shoes, as well as for the significant part of wearing apparel - jackets, trousers, skirts, suits, ensembles, blouses and shirts etc. The trend of share of cross-boarder sub-contracting to be over 60% has been retained
