

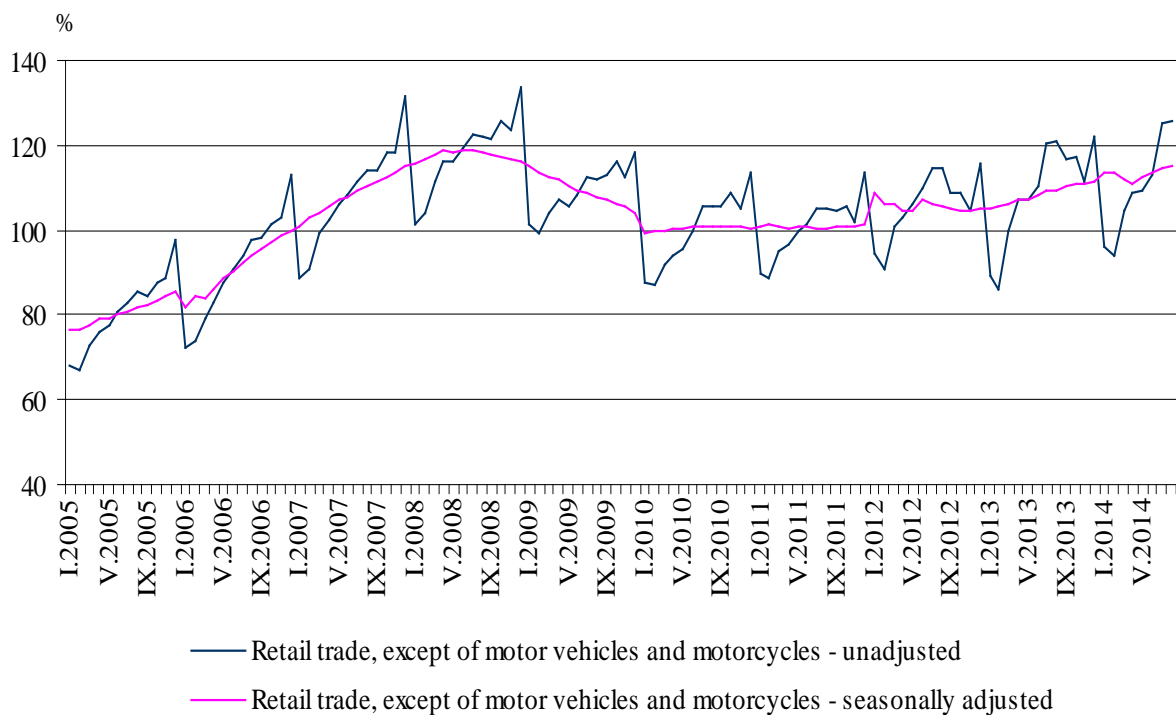


TURNOVER INDICES IN 'RETAIL TRADE, EXCEPT OF MOTOR VEHICLES AND MOTORCYCLES' IN AUGUST 2014^{1,2}

According to the preliminary seasonally adjusted data³ in August 2014 the turnover in '**Retail trade, except of motor vehicles and motorcycles**' at constant prices increased by 0.4% compared to the previous month.

In August 2014 the working day adjusted⁴ turnover in '**Retail trade, except of motor vehicles and motorcycles**' grew by 4.5 % in comparison with the same month of the previous year.

¹ The data for August 2014 are preliminary.

² The monthly turnover indices reflect the short-term changes in the value of this indicator between two compared periods at constant prices. The information may be used to assess the current situation and the trends in the development of the trade sector as well as for short-term forecasts. In order to calculate the indices trade enterprises are observed by using a representative sample that forms about 70% of the annual receipts of the observed aggregate. The monthly turnover indices are calculated with 2010 as a base year.

³ Seasonal adjustment is a statistical method which eliminates the seasonal component of time series.

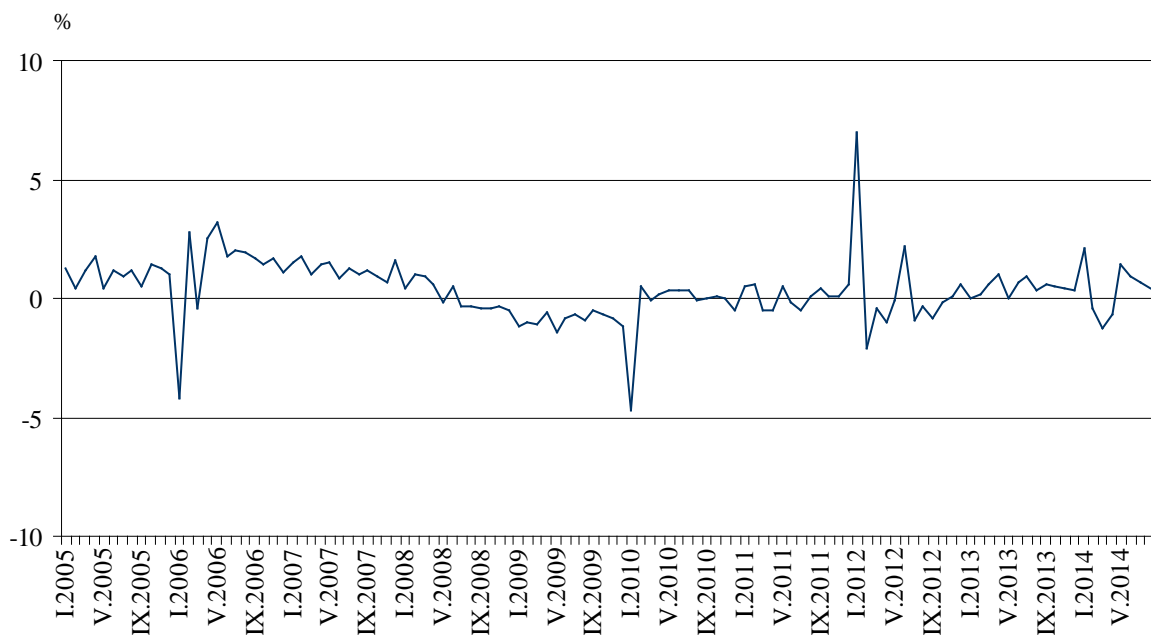
⁴ Working day adjustment is an adjustment for variations caused by calendar effects, different number of calendar and working days in the months, national holydays and outliers (for example the presence of more non-working days in May could contribute to the decline in the retail trade).



Monthly changes

In August 2014 compared to the previous month **the turnover** increased in the 'Retail sale of automotive fuel' by 1.9%, in the 'Dispensing chemist; retail sale of medical and orthopaedic goods, cosmetic and toilet articles' by 1.3% and in the 'Retail sale of food, beverages and tobacco' by 0.1%. A decrease was registered in the 'Retail sale via mail order houses or via Internet' - 1.8%, in the 'Retail sale in non-specialised stores' - 0.5%, in the 'Retail sale of textiles, clothing, footwear and leather goods' and in the 'Retail sale of computers, peripheral units and software; telecommunications equipment' - 0.4% and in the 'Retail sale of audio and video equipment; hardware, paints and glass; electrical household appliances' - 0.2%.

Annual changes

In August 2014 compared to the same month of 2013 **the turnover** increased more significantly in the 'Retail sale via mail order houses or via Internet' by 21.0%, in the 'Retail sale of automotive fuel' by 11.1%, in the 'Retail sale of computers, peripheral units and software; telecommunications equipment' by 5.5% and in the 'Retail sale of food, beverages and tobacco' by 4.8%. A drop was registered in the 'Retail sale in non-specialised stores' - 4.1% and in the 'Retail sale of audio and video equipment; hardware, paints and glass; electrical household appliances' - 1.3%.
