## TURNOVER INDICES IN 'RETAIL TRADE, EXCEPT OF MOTOR VEHICLES AND MOTORCYCLES' JUNE 2021,1,2

According to the preliminary seasonally adjusted data ${ }^{3}$ in June 2021 the turnover in 'Retail trade, except of motor vehicles and motorcycles' at constant prices increased by $1.5 \%$ compared to the previous month.
In June 2021, the calendar adjusted ${ }^{4}$ turnover in 'Retail trade, except of motor vehicles and motorcycles' grew by $22.7 \%$ in comparison with the same month of 2020 .

## Monthly changes

In June 2021, compared to the previous month, an increase of turnover was observed in 'Retail sale of nonfood products (except fuel)' - by $2.3 \%$ and in 'Retail sale of food, beverages and tobacco' - by $1.8 \%$, while in 'Retail sale of automotive fuel in specialized stores' a decrease was reported - by $0.4 \%$.

In 'Retail sale of non-food products (except fuel)' a major growth of turnover was registered: in 'Retail sale of computers, peripheral units and software; telecommunications equipment'- by $6.8 \%$, in 'Dispensing chemist; retail sale of medical and orthopaedic goods, cosmetic and toilet articles in specialised stores' - by $6.1 \%$, and in 'Retail sale via mail order houses or via Internet' - by $6.0 \%$. A drop was noted in 'Retail sale of textiles, clothing, footwear and leather goods in specialised stores' - by $30.8 \%$.

## Annual changes

In June 2021, compared to the same month of 2020, a rise of turnover was reported in 'Retail sale of nonfood products, (except fuel)' (29.3\%), in 'Retail sale of food, beverages and tobacco' ( $16.7 \%$ ) and in 'Retail sale of automotive fuel in specialised stores' ( $15.9 \%$ ).

A growth of turnover in 'Retail sale of non-food products, (except fuel)' was registered in all groups. The growth was more considerable in 'Dispensing chemist; retail sale of medical and orthopaedic goods, cosmetic and toilet articles in specialised stores' - by $47.8 \%$ and in 'Retail sale of computers, peripheral units and software; telecommunications equipment' - by $37.5 \%$.

    ${ }^{2}$ The monthly turnover indices reflect the short-term changes in the value of this indicator between two compared periods at constant prices. The information may be used to assess the current situation and the trends in the development of the trade sector as well as for short-term forecasts. In order to calculate the indices trade enterprises are observed by using a representative sample that forms about $70 \%$ of the annual receipts of the observed aggregate. The monthly turnover indices are calculated with 2015 as a base year.
    ${ }^{3}$ Seasonal adjustment is a statistical method, which eliminates the seasonal component of time series.
    ${ }^{4}$ Calendar adjustment is an adjustment for variations caused by calendar effects, different number of calendar and working days in the months, national holidays and outliers (for example the presence of more non-working days in May could contribute to the decline in the retail trade).
