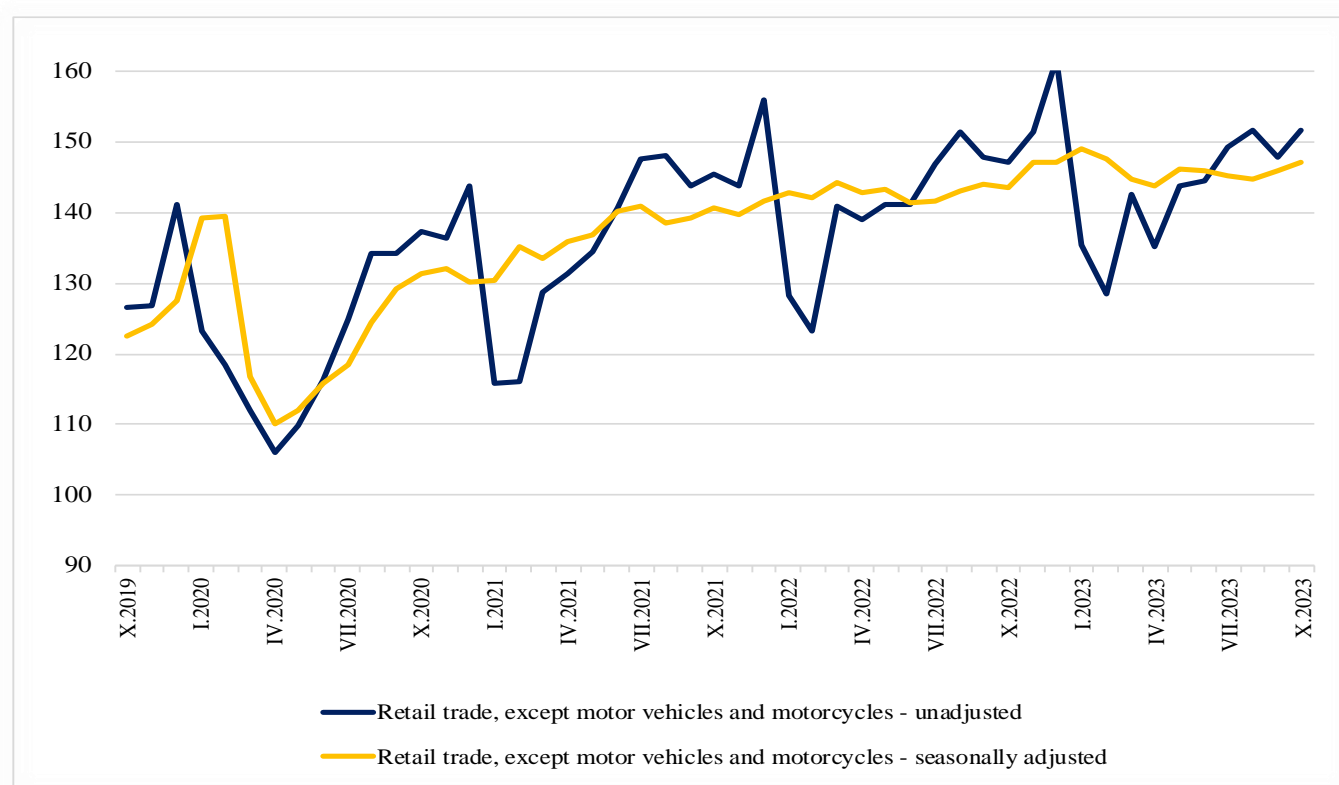


## TURNOVER INDICES IN ‘RETAIL TRADE, EXCEPT MOTOR VEHICLES AND MOTORCYCLES’, OCTOBER 2023<sup>1,2</sup>

In October 2023, the turnover in ‘Retail trade, except motor vehicles and motorcycles’ at constant prices increased by 1.0% compared to the previous month. The data are preliminary and seasonally adjusted<sup>3</sup>.

The calendar-adjusted<sup>4</sup> turnover grew by 3.1% compared to the same month in 2022.

<sup>2</sup> The monthly turnover indices reflect the short-term changes in the value of this indicator between two compared periods at constant prices. The information may be used to assess the current situation and the trends in the development of the trade sector as well as for short-term forecasts. In order to calculate the indices, trade enterprises are observed by using a representative sample that forms about 70% of the annual receipts of the observed aggregate. The monthly turnover indices are calculated with 2015 as a base year.

<sup>3</sup> Seasonal adjustment is a statistical method, which eliminates the seasonal component of time series.

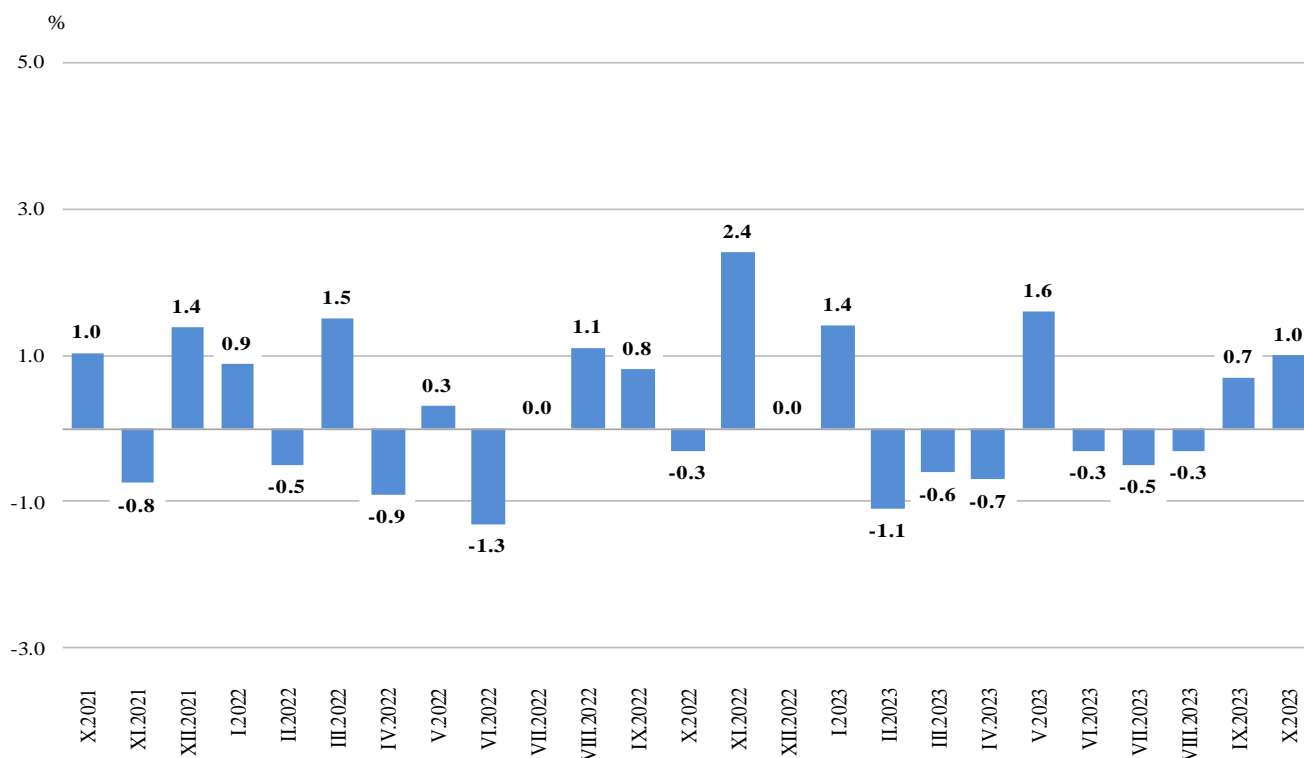
<sup>4</sup> Calendar adjustment is an adjustment for variations caused by calendar effects, a different number of calendar and working days in the months, national holidays and outliers (for example, the presence of more non-working days in May could contribute to the decline in the retail trade).

## Monthly changes

In October 2023, an increase was noted in all major groups: ‘Retail sale of automotive fuel in specialised stores’ - by 3.2%, ‘Retail sale of non-food products (except fuel)’ - by 1.4%, and ‘Retail sale of food, beverages and tobacco’ - by 0.9%.

In ‘Retail sale of non-food products (except fuel)’, more significant increase was reported in ‘Retail sale of computers, peripheral units and software; telecommunications equipment’ - by 6.7%, in ‘Retail sale via mail, order houses or via Internet’ - by 4.3%, and in ‘Retail sale of textiles, clothing, footwear and leather goods’ - by 4.0%.

**Figure 2. Change of turnover in ‘Retail trade, except motor vehicles and motorcycles’ compared to the previous month (Seasonally adjusted)**

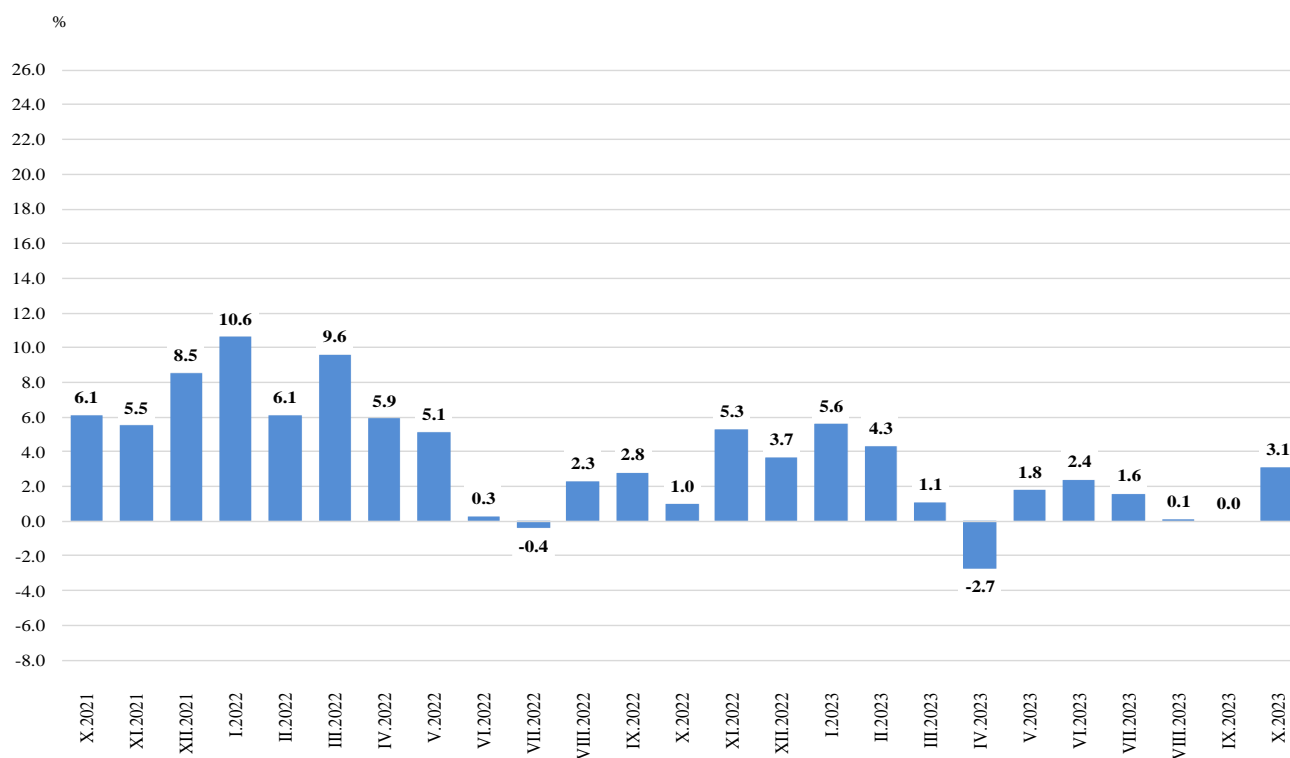


## Annual changes

In October 2023, compared to the same month of 2022, an increase was observed in ‘Retail sale of automotive fuel in specialised stores’ (8.5%) and in ‘Retail sale of food, beverages and tobacco’ (6.8%). A decrease was registered in ‘Retail sale of non-food products (except fuel)’ (0.2%).

In ‘Retail sale of non-food products (except fuel)’ a rise was reported in ‘Retail sale via mail, order houses or via Internet’ - by 18.8%, in ‘Retail sale in non-specialised stores’ - by 7.0%, and in ‘Retail sale of computers, peripheral units and software; telecommunications equipment’ - by 6.9%. Major decline was registered in ‘Retail sale of textiles, clothing, footwear and leather goods’ - by 7.6%, and in ‘Retail sale of audio and video equipment; hardware, paints and glass; electrical household appliances’ - by 4.7%.
