



TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN DECEMBER 2010

In December 2010, the number of the trips of Bulgarian residents in abroad was 254.2 thousand, or 14.7% less than the number of the trips in December 2009 (Table 1). As compared to the same month of 2009 an increase in the total number of the trips was registered namely to: Japan - by 66.7%, Malta - by 52.8%, Portugal - by 36.5%, Israel - by 33.2%, Slovakia - by 32.3%, Sweden - by 15.0%, France - by 6.9%, Austria - by 3.9% and Denmark - by 3.1%. At the same time a decrease in the number of the trips was observed to: Finland - by 49.5%, Turkey - by 24.0%, Serbia - by 23.2%, FYROM - by 22.3%, Ukraine - by 21.6%, Canada - by 17.2%, Netherlands - by 16.4%, Czech. Rep. - by 11.8%, Italy - by 11.1%, Hungary - by 11.1%, Poland - by 10.7% and etc.

The highest share of the trips of Bulgarian citizens travelling abroad had the trips with professional purpose - 45.5%, followed up by holiday and recreation purpose - 25.5%, visits as guests - 25.2%, and others - 3.8%.

In December 2010, the number of arrivals of visitors from abroad to Bulgaria was 374.3 thousand or 4.8% more than the number of trips in the corresponding month of 2009 (Table 2). An increase was registered in the number of visitors passing transit by 9.6%. The visits with holiday and recreation purpose and visits with other purposes were increased by 7.2 and 0.9% respectively. At the same time, a decrease was recorded in visits with professional purpose by 3.7% and as guests by 1.8%.







Figure 2. Number of arrivals of visitors to Bulgaria from abroad by purpose of visit

The arrivals of visitors from EU Member States fell by 2.0%, while the highest drop was observed in the number of visits from Ireland and Malta - 63.3 and 47.5% respectively. An increase was registered in the visits from Romania - by 18.2%, Spain - by 14.1%, Poland - by 9.9%, etc.

The visits of foreigners in the group "Other European countries"¹ were increased by 15.1%. The largest growth was observed in the number of arrivals of citizens from Serbia - by 52.2%, Norway - by 46.1% and Switzerland - by 25.5%.

In December 2010, arrivals by transit trips composed the greatest share of the total number of foreigners visited to Bulgaria - 34.1%, followed by purpose holiday and recreation - 32.1%, professional purpose - 16.1%, others - 14.6% and visits as guests - 3.1%.

Methodological notes

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens of "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens on the border check points.
