


TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN MARCH 2012

In March 2012 **the number of the trips of Bulgarian residents abroad** was 308.1 thousand or by 36.0% more than in February 2012 and by 4.3% above the registered in March 2011 (Figure 1). An increase in the total number of the trips of Bulgarian residents compared to the same month of the previous year was registered to: Serbia - by 140.8%, FYROM - by 122.9%, Austria - by 59.5%, the United Kingdom - by 45.8%, Germany - by 33.8% and etc. At the same time the greatest decrease was observed to Greece - by 55.5% and Romania - by 24.3%.




The trips with holiday and recreation purposes composed the greatest share of the total number of trips of Bulgarian residents abroad - 40.4%, followed by the trips with professional purpose - 31.8% and with other purposes (as guest, education and visit the cultural and sport events) - 27.8%. The trips with holiday and recreation purpose and these with other purposes increased by 7.2 and 21.2% respectively, while a drop in the trips with professional purpose was registered - by 9.8%.

In March 2012 the trips with professional purpose formed 79.0% from all trips to Romania, 73.5% - to Germany, 61.4% - to Italy and 51.1% - to Greece. Predominated share of the trips to Spain and FYROM was with holiday and recreation purpose - 63.7% and 56.2% respectively, while the trips to the Turkey connected with other purpose of visits were 60.3% of all trips of Bulgarian residents to these countries.




Figure 2. Structure of trips of Bulgarian residents abroad by purpose of visit and by countries in March 2012





In March 2012, **the number of arrivals of visitors from abroad to Bulgaria** was 336.9 thousand which was by 20.5% more compared to February 2012 as remains on its level of March 2011 (Figure 3). An increase was registered in the visits with holiday and recreation purpose, and professional purpose - by 1.7% and 8.4% respectively, while the visits with other purposes decreased by 3.7%.



In March 2012 the arrivals of visitors from EU Member States decreased by 3.0% in comparison with the same month of the previous year. However a growth was registered in the visits from Austria – by 27.0% Germany - 14.7% and Romania - by 7.2%. A significant decrease was observed in the visits of the citizens from Greece – by 14.3% and the United Kingdom - by 11.6%.

The visits of foreigners in the group "Other European countries"¹ increased by 4.0% as the highest growth was observed from Russian Federation citizens - by 15.3%.


In March 2012 the visitors with other purposes (including as guest and passing transit) composed the greatest relative share of the total number of foreigners visited Bulgaria - 42.8%, followed by the arrivals with holiday and recreation purpose - 40.2% and professional purpose - 17.0%.

¹ Group of "Other European countries" include countries in Europe outside EU.



The visits with holiday and recreation purpose formed 78.5% of the arrivals from FYROM, from the United Kingdom - 63.5% and from Serbia - 62.4%. The visits with professional purpose were 39.0% of all arrivals from Austria, while with other purpose were 74.2% of the arrivals from Turkey.

METHODOLOGICAL NOTES

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens of "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens on the border check points.
