



## TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN NOVEMBER 2012




Figure 1. Trips of Bulgarian residents abroad by months

In November 2012 **the number of the trips of Bulgarian residents abroad** was 252.3 thousand or by 10.4% less than in October 2012 and by 0.6% under the registered in November 2011 (Figure 1). In comparison with the same month of the previous year a decrease in the total number of the trips of Bulgarian residents was reported to: Greece - by 16.5%, Serbia - by 16.4%, Romania - by 12.1%, Germany - 10.9%, FYROM - 5.5%, and etc. At the same time an increase was observed to: Austria - by 37.5%, Turkey - by 7.6%, the United Kingdom - by 1.2%, and etc. (Annex, Table 1).


The trips with other purposes (as guest, education and visit the cultural and sport events) composed the greatest share of the total number of trips of Bulgarian residents abroad - 56.0%, followed by the trips with professional purpose - 25.2% and with holiday and recreation purposes - 18.8%. In comparison with November 2011 an increase in the trips with other purposes - by 102.6% was observed, while a decrease in these with professional and with holiday and recreation purposes was registered - by 49.5 and 18.5% respectively.

In November 2012 the trips with other purposes formed 69.2% from all trips to Turkey, 60.2% - to Greece and Serbia, and 49.3% to FYROM. Predominated share of the trips to the United Kingdom and Ukraine was with professional purpose - 53.3 and 41.4% respectively, while to Italy and Spain they were connected with holiday and recreation purpose - 36.9 and 33.3% respectively of all trips of Bulgarian residents to these countries (Figure 2).




Figure 3. Arrivals of visitors from abroad to Bulgaria by months

In November 2012, **the number of arrivals of visitors from abroad to Bulgaria** was 404.6 thousand which was by 22.8% less compared to October 2012 and by 5.4% above the level from November 2011 (Figure 3). Compared to November 2011 an increase in the visit with all observed purposes was registered. It was the greatest for the visits with holiday and recreation purpose - by 9.9%. The arrivals with professional purpose rose by 6.1% and with other purposes - by 2.1% compared to November 2011.

The visits of the citizens of European Union composed the greatest relative share of the total number of foreigners visited Bulgaria - 54.3%, followed by these from the other European countries - 34.3% (Annex, Table 2). In comparison with the same month of the previous year the arrivals of visitors from EU Member States increased by 3.3%. A significant increase was observed in the visits of the citizens from Spain - by 13.2%, France - 12.5%, Germania - 11.7%, Austria - by 9.9% etc. However a drop in the visits from the United Kingdom - by 13.1% and Italy - by 6.1% was registered.

The visits of foreigners in the group "Other European countries" increased by 9.2% as the highest growth was observed in the visits of citizens of Russian Federation and Serbia - by 29.7 and 17.4% respectively.

In November 2012 the predominated share of the total number of the visits to Bulgaria were with other purposes (including as guest and passing transit) - 48.2% followed by the arrivals with holiday and recreation purpose - 34.6% and with professional purpose - 17.2%.

The visits with holiday and recreation purpose formed 77.9% of the arrivals from FYROM, 65.7% - from Serbia and 47.7% - from Russia. The visits with professional purpose were 55.9% of all arrivals from Belgium and 48.7% - from Austria, while with other purpose were 74.8% of the arrivals from Turkey, 70.1% - from Ukraine and 55.0% from Romania and 50.9% - from Greece (Figure 4).



## **Methodological notes**

The definitions recommended by the World Tourist Organization and Methodological manual for tourism by Eurostat are applied by National Statistical Institute.

In accordance with these definitions **an international tourist** is any person who travels to a country other than his/her permanent residence at least 24 hours but no more than one year and whose main purpose is not doing any activity for payment.

The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical sightseeing, sports events and other);
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, etc.);
- Other (education, cure, etc.) purposes.

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens of "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens on the border check points.
