

TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN MAY 2013

In May 2013 **the number of the trips of Bulgarian residents abroad** was 361.9 thousand or by 3.9% above the registered in May 2012 (Figure 1). In comparison with the same month of the previous year an increase was reported in the total number of the trips of Bulgarian residents to: Russian Federation - by 191.4%, Belgium - by 175.0%, Austria - 117.9%, France - by 91.1%, Italy - by 87.1%, Germany - by 82.9%, and etc. At the same time a decrease was observed in the total number of the trips of Bulgarian residents to: Turkey - by 28.2%, Serbia - by 17.2% FYROM - by 12.5%, and etc. (Annex, Table 1).

The trips with other purposes (as guest, education and visit the cultural and sport events) composed the greatest share of the total number of trips of Bulgarian residents abroad - 45.7%, followed by the trips with holiday and recreation purposes - 31.8% and with professional purpose - 22.5%. In comparison with May 2012 an increase was observed in the trips with other purposes - by 75.2%, while a decrease was registered in these with professional and with holiday and recreation purposes - by 39.0 and by 4.6% respectively.




Figure 2. Structure of the trips of Bulgarian residents abroad by purpose of visit and by country of destination in May 2013

In May 2013 the trips with other purposes formed 67.0% from all trips to Spain, 66.7% - to the United Kingdom, 63.6% - to Turkey and 60.3% - to Serbia. Predominated share of the trips to Belgium and Czech Republic was with professional purpose - 73.7 and 47.5% respectively. The trips with holiday and recreation purpose to Romania were 69.1%, to Greece - 42.3% and to France - 39.4% from all trips of Bulgarian residents to these countries (Figure 2).




Figure 3. Arrivals of visitors from abroad to Bulgaria by months

In May 2013, **the number of arrivals of visitors from abroad to Bulgaria** was 634.8 thousand which was by 4.8% above the level in May 2012 (Figure 3). An increase was registered in the visits with holiday and recreation purposes - by 10.3% as well in the trips with other purposes - by 3.8%, while the professional visits decreased by 7.3%.

The visits of the citizens of European Union composed the greatest relative share of the total number of the foreigners visited Bulgaria - 59.2%, (Annex, Table 2) as in comparison with the same month of the previous year they decreased by 1.0%. A decrease was registered in the visits of the citizens from Czech Republic - by 3.7%, Italy - by 3.3%, Romania - by 2.7%, the United Kingdom - by 2.5%, Greece - 1.8% and etc. At the same time a growth was registered in the visits of citizens from Austria - by 13.2%, Germany - by 6.5%, France - by 4.7%, Belgium - by 4.4%, and Spain - by 4.1%.

The visits of foreigners in the group "Other European countries"¹ increased by 17.5% as the highest growth was observed in the visits of citizens of Russian Federation and Ukraine - by 41.0 and by 36.8% respectively.

In May 2013 the share of the visits with holiday and recreation purpose predominated (44.9%), followed by these with other purposes (including as guest and passing transit) - 40.7% and with professional purpose - 14.4%.




Figure 4. Structure of the arrivals of visitors to Bulgaria from abroad by purpose of visit and by country of origin in May 2013

The visits with holiday and recreation purpose formed 79.3% of the arrivals from FYROM, 67.0% - from Russian Federation, 64.1% - from the United Kingdom, 58.8% - from Serbia and 53.6% - from Czech Republic. The visits with professional purpose were 38.1% of all arrivals from Spain, 34.6% - from France, while with other purpose were 70.2% of the arrivals from Turkey, 54.4% - from Ukraine and 45.5% - from Italy (Figure 4).

Methodological notes

The definitions recommended by the World Tourist Organization and Methodological manual for tourism by Eurostat are applied by National Statistical Institute.

In accordance with these definitions **an international tourist** is any person who travels to a country other than his/her permanent residence at least 24 hours but no more than one year and whose main purpose is not doing any activity for payment.

The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical sightseeing, sports events and other);
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, etc.);
- Other (education, cure, etc.) purposes.

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens of "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens on the border check points.
