

TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN AUGUST 2013




Figure 1. Trips of Bulgarian residents abroad by months

In August 2013, **the number of the trips of Bulgarian residents abroad** was 447.8 thousand or by 8.5% above the registered in August 2012 (Figure 1). In comparison with the same month of the previous year an increase was reported in the total number of the trips of Bulgarian residents to: Greece - by 48.3%, France - by 43.5%, Serbia - by 43.3%, Austria - by 14.3%, and etc. At the same time a decrease was observed in the total number of trips to: Turkey - by 25.2%, Spain - by 22.1%, and etc. (Annex, Table 1).

The trips with other purposes (as guest, education and visit the cultural and sport events) composed the greatest share of the total number of trips of Bulgarian residents abroad - 44.3%, followed by the trips with holiday and recreation purposes - 36.0% and with professional purpose - 19.7%. In comparison with August 2012 an increase in the trips with all observed purposes was registered, as the trips with professional purpose increased by 21.2% and those with other purposes and for holiday and recreation - by 10.2 and 0.7% respectively.




Figure 2. Structure of the trips of Bulgarian residents abroad by purpose of visit and country of destination in August 2013

In August 2013 the trips with other purposes formed 63.1% from all trips to Turkey, 58.1% to the United Kingdom, 52.8% - to FYROM and 50.0% - to Russian Federation. The predominated share of the trips to Romania and Austria were with professional purpose - 43.2% and 41.0% respectively. The trips with holiday and recreation purpose to Greece were 54.6%, to Serbia - 46.3%, and to Spain - 45.0% from all trips of Bulgarian residents to these countries (Figure 2).




Figure 3. Arrivals of visitors from abroad to Bulgaria by months

In August 2013, **the number of arrivals of visitors from abroad to Bulgaria** was 1 710.5 thousand which was by 4.4% above the level in August 2012 (Figure 3). An increase was registered in the visits by all observed purposes: professional - by 7.6%, for holiday and recreation - by 5.9%, and with other purposes - by 1.1%.

The visits of the citizens of European Union composed the greatest relative share of the total number of the foreigners visited Bulgaria - 61.7%, (Annex, Table 2) as in comparison with the same month of the previous year they increased by 0.3%. An increase was registered in the visits of the citizens of Denmark - by 6.1%, Greece – by 4.3%, Finland - by 3.1%, Germany - by 2.8%, and etc. At the same time a decrease in the visits of citizens of Slovakia - by 10.0%, the Netherlands - by 8.3%, Czech Republic - by 4.7%, Hungary - by 4.5%, and etc was reported.

The visits of foreigners in the group "Other European countries"¹ increased by 10.6% as the highest growth was observed in the visits of citizens of Russian Federation and Ukraine - by 15.5% and 13.3% respectively.

In August 2013, the predominated share of the visits with holiday and recreation purpose - 63.6% followed by these with other purposes (including as guest and passing transit) - 31.2% and with professional purpose - 5.2%.




Figure 4. Structure of the arrivals of visitors to Bulgaria from abroad by purpose of visit and country of origin in August 2013

The visits with holiday and recreation purpose formed 89.4% of the arrivals from Denmark, 88.9% - from Czech Republic, 88.8% - from Russian Federation, 84.6% - from the United Kingdom, 82.6% - from FYROM, 80.5% - from Poland, and 80.2% - from Ukraine. The visits with professional purpose were 20.5% of all arrivals from Italy, while with other purpose were 80.4% of the arrivals from Turkey (Figure 4).

www.nsi.bg Methodological notes

The definitions recommended by the World Tourist Organization and Methodological manual for tourism by Eurostat are applied by National Statistical Institute.

In accordance with these definitions **an international tourist** is any person who travels to a country other than his/her permanent residence at least 24 hours but no more than one year and whose main purpose is not doing any activity for payment.

The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical sightseeing, sports events and other);
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, etc.);
- Other (education, cure, etc.) purposes.

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens of "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens on the border check points.
