

TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN MARCH 2014




Figure 1. Trips of Bulgarian residents abroad by months

In March 2014, **the number of the trips of Bulgarian residents abroad** was 313.4 thousand or by 1.5% above the registered in March 2013 (Figure 1). In comparison with the same month of the previous year an increase was observed in the total number of the trips of Bulgarians to FYROM - by 16.1%, Turkey - by 11.5%, Greece - by 1.1%, and etc. At the same time a decrease was observed in the total number of the trips of Bulgarians to Russian Federation - by 27.9%, Czech Republic - by 16.1%, France - by 8.7%, the United Kingdom - by 8.4%, Austria - by 7.7%, Romania - by 7.4%, Serbia - by 6.9%, Germany - by 4.8% and etc. (Annex, Table 1).


In March 2014, the trips with other purposes (as guest, education and visit the cultural and sport events) composed the greatest share of the total number of trips of Bulgarian residents abroad - 44.5%, followed by the trips with holiday and recreation purposes - 29.0% and with professional purpose - 26.5%. In comparison with March 2013, an increase in the trips with holiday and recreation purposes - by 86.5% was observed, while a decrease in these with other purposes and with professional purposes by 20.4 and 2.0% respectively was registered.

In March 2014, the trips with other purposes formed 57.1% of all trips to Czech Republic, 55.3% - to Greece, 52.8% - to the United Kingdom and 52.6% - to Russian Federation. The predominant share of the trips to Belgium and FYROM was with professional purpose - 45.8 and 40.3% respectively, while the trips with holiday and recreation purpose to Serbia were 43.3% of all trips of Bulgarian residents to these countries (Figure 2).




Figure 3. Arrivals of visitors from abroad to Bulgaria by months

In March 2014, the number of arrivals of visitors from abroad to Bulgaria was 361.1 thousand which was by 2.4% above the level of March 2013 (Figure 3). An increase was registered in the visits with holiday and recreation purpose, and with other purposes - by 4.4 and 2.1% respectively, while these with professional purposes decreased by 1.9%.

The share of visits of EU citizens was 46.6% of the total number of foreigners' visits to Bulgaria in March 2014 (Annex, Table 2) as in comparison with the same month of the previous year marked the growth of 3.5%. An increase was registered in the visits of the citizens of Italy - by 16.7%, Hungary - by 9.4%, the United Kingdom - by 9.0%, Austria - by 8.3%, Romania - by 8.3%, Germany - by 6.5, and etc. At the same time decreased the visits from Greece - by 7.2%, Poland - 4.3%, and etc.

The visits of foreigners in the group "Other European countries" increased by 1.7% as the highest growth was observed in the visits of citizens of FYROM and Serbia - by 6.0 and 5.4% respectively.

In March 2014, the predominant share of the visits with holiday and recreation purpose was - 43.3%, followed by these with others purposes (including as guest and passing transit) - 39.3% and with professional purpose - 17.4%.

The visits with holiday and recreation purposes formed 80.4% of the arrivals from FYROM, 62.9% - from Serbia, and 62.8% - from Russian Federation. The visits with professional purposes were 46.4% of all arrivals from Italy and 40.4% - from Austria, while with other purpose were 64.9% of the arrivals from Turkey and 59.9% from Belgium (Figure 4).



Methodological notes

The definitions recommended by the World Tourist Organization and the Methodological manual for tourism by Eurostat are applied by the National Statistical Institute.

In accordance with these definitions **an international tourist** is any person who travels to a country other than his/her permanent residence for at least 24 hours but no more than one year and whose main purpose is not doing any activity for payment.

The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical landmarks, sport events and other):
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, etc.);
- Other (education, medical treatment, etc.) purposes.

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners to Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing through border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens from "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are obtained on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens through the border check points.
