



TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN JULY 2019





Figure 1. Trips of Bulgarian residents abroad by months

In July 2019, **the number of the trips of Bulgarian residents abroad** was 779.5 thousand (Annex, Table 1) or by 7.2% above the registered in July 2018 (Figure 1). In comparison with the same month of the previous year, an increase was observed in the total number of the trips of Bulgarians to: the United Kingdom - by 11.4%, Romania - by 11.2%, Turkey - by 8.4%, Germany - by 8.1%, Greece - by 6.9%, Republic of North Macedonia - by 4.8%, Spain - by 4.5%, Austria - by 3.8%, and etc. At the same time decreased the trips to: Italy - by 3.8%, Serbia - by 2.3%, the Netherlands - by 2.3%, and etc.

In comparison with July 2018, an increase was registered in the trips with all observed purposes: 'others' - by 7.5%, 'holiday and recreation' - by 6.9% and 'professional' - by 6.9%. The trips with other purposes (as a guest, education and visit the cultural and sport events) in July 2019 composed the greatest share of the total number of trips of Bulgarian residents abroad - 40.7%, followed by those with holiday and recreation purpose - 39.7%, and with professional purpose - 19.6% (Figure 2).





Figure 2. Structure of the trips of Bulgarian residents abroad by purpose of visit in July 2019




In July 2019 most trips of Bulgarian citizens were made to: Turkey - 181.3 thousand, Greece - 160.7 thousand, Germany - 71.5 thousand, Romania - 69.8 thousand, Serbia - 37.3 thousand, Republic of North Macedonia - 34.9 thousand, Italy - 27.7 thousand, Austria - 23.5 thousand, the United Kingdom - 21.9 thousand, Spain - 19.3 thousand (Figure 3).




Figure 4. Arrivals of visitors from abroad to Bulgaria by months

In July 2019, the number of arrivals of visitors from abroad to Bulgaria was 2 083.1 thousand (Annex, Table 2) or by 3.2% less in comparison with July 2018 (Figure 4). A decrease was registered in the trips with purpose 'holiday and recreation' - by 6.2%, while those with 'professional' and 'others' (including as guest and passing transit) purposes increased by 1.7% and 0.4% respectively. Transit passes through the country were 26.0% (542.5 thousand) of all visits of foreigners to Bulgaria.

The share of visits of EU citizens was 60.1% of the total number of foreigners' visits to Bulgaria in July 2019 or by 5.2% less in comparison with the same month of the previous year. An increase was registered in the visits of citizens from the United Kingdom - by 21.0%, Ireland - by 19.1%, Hungary - by 6.5%, Romania - by 6.1%, Spain - by 3.5%, France - by 1.6%, and etc. At the same time decreased the visits from Czech Republic - by 13.9%, Germany - by 12.9%, Poland - by 11.6%, Greece - by 7.6%, and etc.

The visits of foreigners in the group 'Other European countries' decreased by 0.2%, as the highest decrease was observed in the visits of citizens of Russian Federation - by 15.7%.




Figure 5. Structure of visits of foreign citizens to Bulgaria by purpose in July 2019

In July 2019, the predominant share of the visits with holiday and recreation purpose was 55.5%, followed by trips with other purposes - 36.7%, and with professional purpose - 7.8% (Figure 5).



In July 2019 the most visits to Bulgaria were from: Romania - 314.3 thousand, Turkey - 212.3 thousand, Germany - 204.1 thousand, Greece - 128.5 thousand, Ukraine - 127.5 thousand, Russian Federation - 115.5 thousand, Poland - 106.1 thousand, the United Kingdom - 87.7 thousand, Serbia - 72.4 thousand, Czech Republic - 60.5 thousand (Figure 6).

Methodological notes

The definitions recommended by the World Tourist Organization and the Methodological manual for tourism by Eurostat are applied by the National Statistical Institute.

In accordance with these definitions **an international tourist** is any person who travels to a country other than his/her permanent residence for less than a year and whose main purpose is not doing any activity for payment in place visited.

The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical landmarks, sport events and other);
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, and etc.);
- Other (education, medical treatment, and etc.) purposes.

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners to Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing through border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens from 'third countries' are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are obtained on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens through the border check points.
