




# TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA<sup>1</sup> IN MARCH 2021

In March 2021, in the conditions of the continuing epidemic situation, **the number of the trips of Bulgarian residents abroad** was 251.5 thousand, or by 9.0% above the registered in March 2020 when the state of emergency first was introduced in the country in connection with the global spread of the COVID-19 (Figure 1).




Figure 2. Arrivals of visitors from abroad to Bulgaria by months

In March 2021, the number of arrivals of visitors from abroad to Bulgaria was 287.9 thousand (Annex, Table 1) or by 8.0% less in comparison with March 2020 (Figure 2). A collapse in the trips with 'holiday and recreation' purpose - by 56.8%, was registered, while those with 'others' (including as guest and passing transit) and 'professional' purpose increased - by 13.3% and 1.4%. Transit passes through the country were 58.2% (167.4 thousand) of all visits of foreigners to Bulgaria.

The share of visits of EU citizens was 37.5% of the total number of foreigners' visits to Bulgaria in March 2021 or by 30.5% less in comparison with the same month of the previous year. A decrease in visits by citizens from Greece - by 65.0%, Spain - by 43.6%, France - by 13.2%, the Netherlands - by 11.7%, Belgium - by 7.4%, Romania - by 2.5%, and others was registered. At the same time, the visits of citizens from the Czechia increased by 85.2%, Austria - by 42.5%, Italy - by 41.1%, Germany - by 26.1%, and others.






The visits of foreigners in the group 'Other European countries' increased by 15.4%, as the highest increase was observed in the visits of citizens of Turkey - with 34.8%.

In March 2021, the relative share of visits by purpose was as follows: with other purposes - 66.0%, with professional purpose - 21.3%, and with holiday and recreation purpose - 12.7% (Figure 3).

### **Methodological notes**

The definitions recommended by the World Tourist Organization and the Methodological manual for tourism by Eurostat are applied by the National Statistical Institute.

In accordance with these definitions, **an international tourist** is any person who travels to a country other than his/her permanent residence for less than a year and whose main purpose is not doing any activity for payment in place visited.

## The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical landmarks, sport events and other);
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, and etc.);
- Other (education, medical treatment, and etc.) purposes.

In March 2021, due to the impossibility to conduct the statistical survey at the border checkpoints, all statistical data on the trips of Bulgarians abroad and the visits of foreigners in Bulgaria - total and for the purpose of the trip - were provided to the NSI by the Ministry of Interior.
