
TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN APRIL 2022


Figure 1. Trips of Bulgarian residents abroad by months

In April 2022, **the number of the trips of Bulgarian residents abroad** was 590.5 thousand (Annex, Table 1) or by 117.7% above the registered in April 2021 (Figure 1).


The trips with other purposes (as a guest, education and visit the cultural and sport events) in April 2022 composed the greatest share of the total number of trips of Bulgarian residents abroad - 44.2%, followed by those with holiday and recreation purpose - 28.9%, and with professional purpose - 26.9% (Figure 2).

In April 2022 most trips of Bulgarian citizens were made to: Turkey - 163.8 thousand, Greece - 135.8 thousand, Serbia - 50.9 thousand, Romania - 47.8 thousand, Republic of North Macedonia - 27.4 thousand, Italy - 27.4 thousand, Germany - 20.5 thousand, Austria - 19.2 thousand, Spain - 17.3 thousand, Belgium - 12.1 thousand (Figure 3).




Figure 4. Arrivals of visitors from abroad to Bulgaria by months

In April 2022, **the number of arrivals of visitors from abroad to Bulgaria** was 646.3 thousand (Annex, Table 2) or by 128.8% more in comparison with April 2021 (Figure 4). An increase in the trips with all observed purposes was registered. Transit passes through the country were 42.9% (277.5 thousand) of all visits of foreigners to Bulgaria.


The share of visits of EU citizens was 44.8% of the total number of foreigners' visits to Bulgaria in April 2022 and reached 289.9 thousand. An increase in the visits of citizens from all EU countres was registered.

The visits of foreigners in the group 'Other European countries' were 299.7 thousand, or 46.4% of all visits to Bulgaria. The highest number of visits was registered from Turkey - 123.6 thousand or 41.3% in this group.

¹ Group 'Other European countries' includes countries in Europe outside the EU and all data are provided by the Ministry of Interior.


In April 2022, the predominant share of the visits with other purposes was 56.9%, followed by trips with holiday and recreation purpose - 29.2%, and with professional purpose - 13.9% (Figure 5).

In April 2022 the most visits to Bulgaria were from: Romania - 128.7 thousand, Turkey - 123.6 thousand, Ukraine - 71.9 thousand, Greece - 55.6 thousand, Serbia - 50.8 thousand, Republic of North Macedonia - 33.4 thousand, Germany - 30.8 thousand, Poland - 12.8 thousand, the United Kingdom - 12.7 thousand, Italy - 9.7 thousand (Figure 6).

Methodological notes

The definitions recommended by the World Tourist Organization and the Methodological manual for tourism by Eurostat are applied by the National Statistical Institute.

In accordance with these definitions **an international tourist** is any person who travels to a country other than his/her permanent residence for less than a year and whose main purpose is not doing any activity for payment in place visited.

The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical landmarks, sport events and other);
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, and etc.);
- Other (education, medical treatment, and etc.) purposes.

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners to Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing through border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens from 'third countries' are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are obtained on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens through the border check points.
