

TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN FEBRUARY 2024

In February 2024, **the number of trips of Bulgarian residents abroad** was 499.0 thousand (Annex, Table 1), or 10.7% above the registered in February 2023. An increase was registered in the trips with other purpose - by 22.9%, and with holiday and recreation purposes - by 7.4%, while those with professional purpose decreased by 5.7%.




Figure 1. Trips of Bulgarian residents abroad by months





Figure 2. Top foreign destinations for Bulgarian residents by purpose of visit in February 2024

Most trips of Bulgarian residents were made to: Türkiye - 118.8 thousand, Greece - 93.2 thousand, Romania - 59.5 thousand, Serbia - 42.6 thousand, Republic of North Macedonia - 30.9 thousand, Germany - 28.2 thousand, Austria - 22.4 thousand, Italy - 14.3 thousand, France - 13.6 thousand, Spain - 13.1 thousand (Figure 2).


The trips with other purposes (as a guest, education and visiting cultural and sports events) composed the greatest share of the total number of trips of Bulgarian residents abroad - 49.4%, followed by those with holiday and recreation purposes - 27.6%, and with professional purpose - 23.0%.


Figure 3. Structure of the trips of Bulgarian residents abroad by purpose of visit in February 2024





In February 2024, **the number of visits of non-residents to Bulgaria** was 698.9 thousand (Annex, Table 2), or 15.6% more in comparison with the same month of the previous year (Figure 4). An increase in the trips with all observed purposes was registered - holiday and recreation, professional and others. Transit passes through the country were 31.5% (220.0 thousand) of all visits of non-residents to Bulgaria.






The share of visits of EU citizens was 46.2% of the total number of non-residents' visits to Bulgaria and reached 322.7 thousand, the largest being by visitors from Romania - 43.3%, and Greece - 26.0%.


The visits of non-residents in the group 'Other European countries'¹ were 312.5 thousand, or 44.7% of all visits to Bulgaria. The highest number of visits from Türkiye - 145.0 thousand, or 46.4% in this group, was registered.

Most visits to Bulgaria were from: Türkiye - 145.0 thousand, Romania - 139.7 thousand, Greece - 84.0 thousand, Serbia - 53.1 thousand, Ukraine - 45.2 thousand, the United Kingdom - 35.9 thousand, Republic of North Macedonia - 25.9 thousand, Germany - 18.4 thousand, Italy - 14.0 thousand, Poland - 12.1 thousand (Figure 5).

¹ Group 'Other European countries' includes countries in Europe outside the EU.








The predominant share of the visits was with other purposes - 47.2%, followed by trips with holiday and recreation purposes - 39.1%, and with professional purpose - 13.7%.

Methodological notes

The definitions recommended by the World Tourist Organization and the Methodological manual for tourism by Eurostat are applied by the National Statistical Institute.

In accordance with these definitions, **an international tourist** is any person who travels to a country other than his/her permanent residence for less than a year and whose main purpose is not doing any activity for payment in the place visited.

The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical landmarks, sport events and others);
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, etc.);
- Other (education, medical treatment, etc.) purposes.

Statistical data on the trips of Bulgarian residents travelling abroad and visits by non-residents to Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and a sample survey of the National Statistical Institute among residents and non-residents passing through border checkpoints.

Data on the number of trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens from 'third countries' are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are obtained on the basis of the NSI's regular monthly sample survey of passing residents and non-residents through the border checkpoints.
