


FOREIGN TRADE OF BULGARIA FOR 2010 - FINAL DATA

In 2010 the value of the **exported goods** was **30.4 billion levs** and compared to 2009 the exports increased by 33.0% (Table 1.1 and 1.2). Compared to the same month of the previous year the largest growth was observed in July (by 48.5%) and the lowest in February (by 10.8%).



The value of the imported goods for 2010 was 37.6 billion levs (CIF prices) or 14.0% more than in 2009 (Table 1.1 and 1.2). In most of the months of 2010 growths of imports were observed compared to the corresponding month of the previous year. The largest growth was in November - 41.1%. Falls were reported on the imports in the first two months of the year, respectively 5.5% in January and 11.1% in February. The tendency the imports to be higher than the exports continued in 2010.





Foreign trade balance (exports FOB - import CIF) was negative in 2010 and amounted to 7.2 billion levs, which was 2.9 billion levs less than the balance in 2009 (Table 1.1 and 1.2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) the negative balance in 2010 amounted to 5.4 billion levs.

The **exports** of Bulgaria in 2010 distributed according to the **Standard International Trade Classification** showed growths in all the sections compared to the same period of 2009 (Table 3). The largest growths were recorded in the sections: "Crude materials, inedible (except fuel)"¹(60.4%) and "Mineral fuel, lubricants and related materials"(39.1%).


On **imports** the largest growths were recorded in the sections: "Crude materials, inedible (except fuel) (42.9%) and "Mineral fuel, lubricants and related materials" (28.6%). Fall was reported in section "Machinery and transport equipment".

¹ The section includes the following divisions: Hides, skins and furskins, raw; Oil seeds and oleaginous fruits; Crude rubber (including synthetic and reclaimed); Cork and wood; Pulp and waste paper; Textile fibres (other than wool tops and other combed wool) and their wastes (not manufactured into yarn or fabric); Crude fertilizers, other than those of division 56, and crude minerals (excluding coal, petroleum and precious stones); Metalliferous ores and metal scrap; Crude animal and vegetable materials, n.e.s.




Bulgarian trade with EU

In 2010 the **exports** of Bulgaria to **EU countries** increased by 24.6% compared to the previous year and amounted to 18.5 billion levs (Table 1.1 and 1.2). The main trade partners of Bulgaria were Germany, Italy, Romania, Greece, France and Belgium that formed 74.3% from the exports to EU (Table 2). The exports to Estonia and Slovenia recorded growths by 137.8% and 137.1% respectively. Falls were observed in the exports to Cyprus, Belgium and Malta.



The **Bulgarian imports from EU countries** in 2010 increased by 11.2% compared to the previous year and amounted to 22.0 billion levs (Table 1.1 μ 1.2). The largest growths were recorded in the imports from Malta (259.6%), Portugal (91.1%), Lithuania (55.5%) and Latvia (48.4%). The most notable falls were observed in imports from Estonia and Czech Republic.





Foreign trade balance (exports FOB - import CIF) of Bulgaria with **EU countries** was negative and amounted to 3.5 billion levs in 2010 (Table 1.1).

The **exports** of Bulgaria to **EU** distributed according to the **Standard International Trade Classification** showed that in 2010 compared to 2009 the largest growths were in the exported goods from sections: "Crude materials, inedible (except fuel) (61.7%), "Animals and vegetable oils, fats and waxes" (38.0%) and "Chemical and related products n.e.c." (36.7%). Fall was observed in the section "Beverages and tobacco".

On **imports** from **EU** growths in all the sections were observed except in section "Machinery and transport equipment".

Bulgarian trade with third countries

In 2010 the Bulgarian **exports** to **third countries** increased by 48.5% compared to the previous year and amounted to 11.9 billion levs (Table 1.1 and 1.2). The main trade partners of Bulgaria were Turkey, Serbia, Russia, The Former Yugoslav Republic of Macedonia, that formed over 43% of the exports to non EU countries (Table 2). Exported goods to Turkey increased by 55.6% and those to Russia by 51.1%. Growths of the exports to Peru by 521.4% and Republic of Korea by 337.4% were observed. The largest falls were reported on the exports to United Arab Emirates and Bosnia and Herzegovina.







Figure 5. Nominal growth of exports to non EU countries for the period

Bulgarian **imports from third countries** for 2010 increased by 18.2%, compared to the previous year, and amounted to 15.6 billion levs (Tables1.1 and 1.2). The largest growths were reported on the imports from Egypt (249.5%), Albania (139.8%) and Israel (91.1%). The most notable falls were reported on the imports from Kazakhstan, South Africa and Norway.
