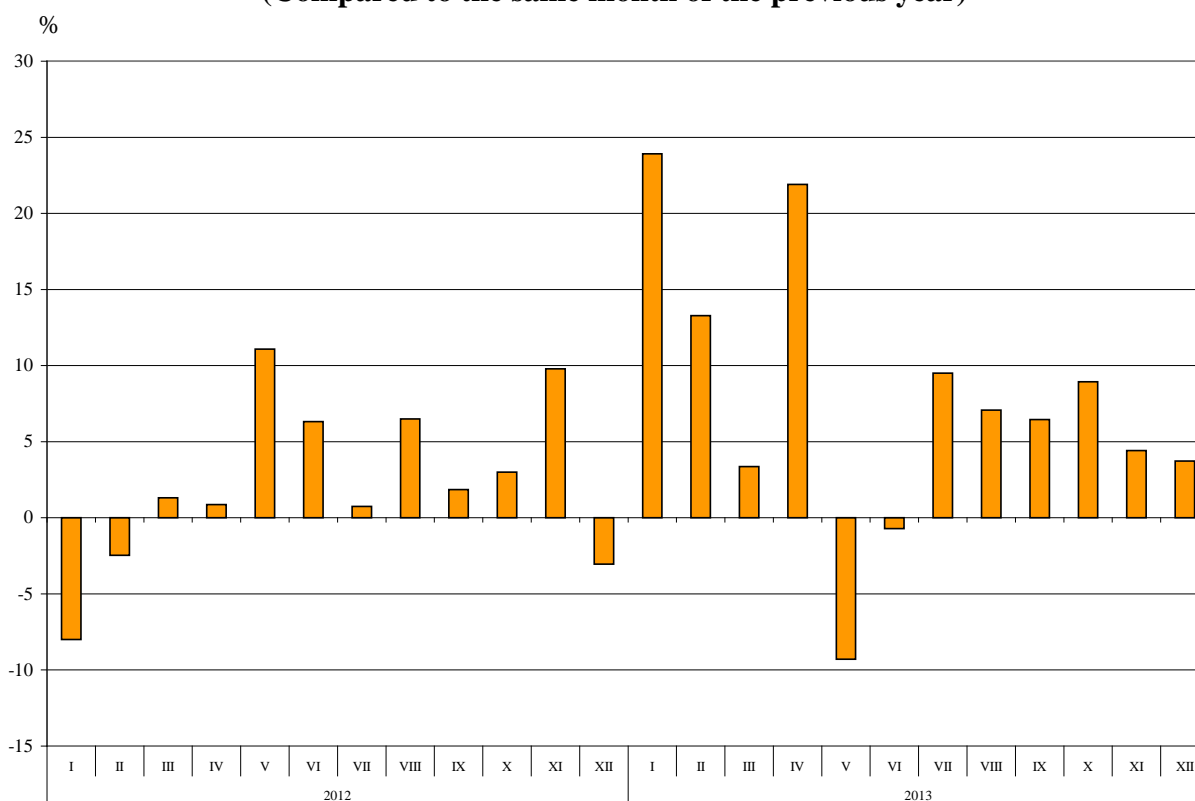




FOREIGN TRADE OF BULGARIA IN 2013 - FINAL DATA

In 2013 the **exported goods** were for 43.6 Billion BGN and compared to 2012 the exports increased by 7.2% (Annex, Table 1 and 2). Compared to the same month of the previous year the largest growth was observed in January (by 23.9%) and the largest fall in May (by 9.3%).

(Compared to the same month of the previous year)**

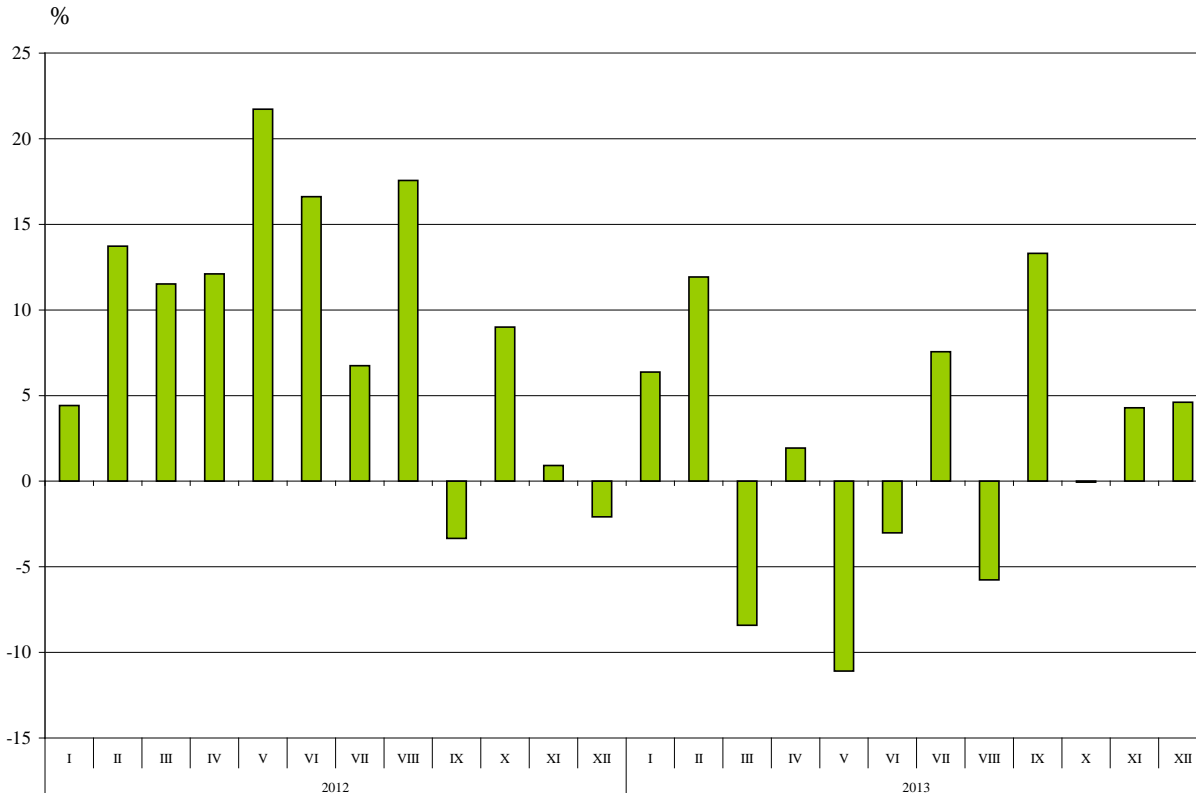


The imported goods in 2013 were for 50.5 Billion BGN (at CIF prices) or 1.4% more than in the previous year (Annex, Table 1 and 2). In 2013 compared to the corresponding month of 2012 the largest growth was observed in September - by 13.3% and the most notable fall was reported in May (by 11.1%). The tendency the imports by months to be higher than the exports continued in 2013 with the exception of August.

Foreign trade balance (exports FOB - import CIF) was negative in 2013 and amounted to 7.0 Billion BGN, which was 2.2 Billion BGN less than the balance in 2012 (Annex, Table 1 and 2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) the negative balance for 2013 added up to 4.8 Billion BGN.

The **exports** of Bulgaria in 2013 distributed according to the Standard International Trade Classification showed an increase in most of the sections compared to 2012 (Annex, Table 4). The largest growth was recorded in the section „Animal and vegetable oils, fats and waxes” (by 30.2%). Fall was reported only in the section “Mineral fuel, lubricants and related materials” (by 2.9%).

In **imports** the largest growths were recorded in the sections: „Beverages and tobacco” (by 10.8%) and “Miscellaneous manufactured articles”² (by 9.9%). The most notable fall was reported in the section “Animal and vegetable oils, fats and waxes” (by 13.4%).

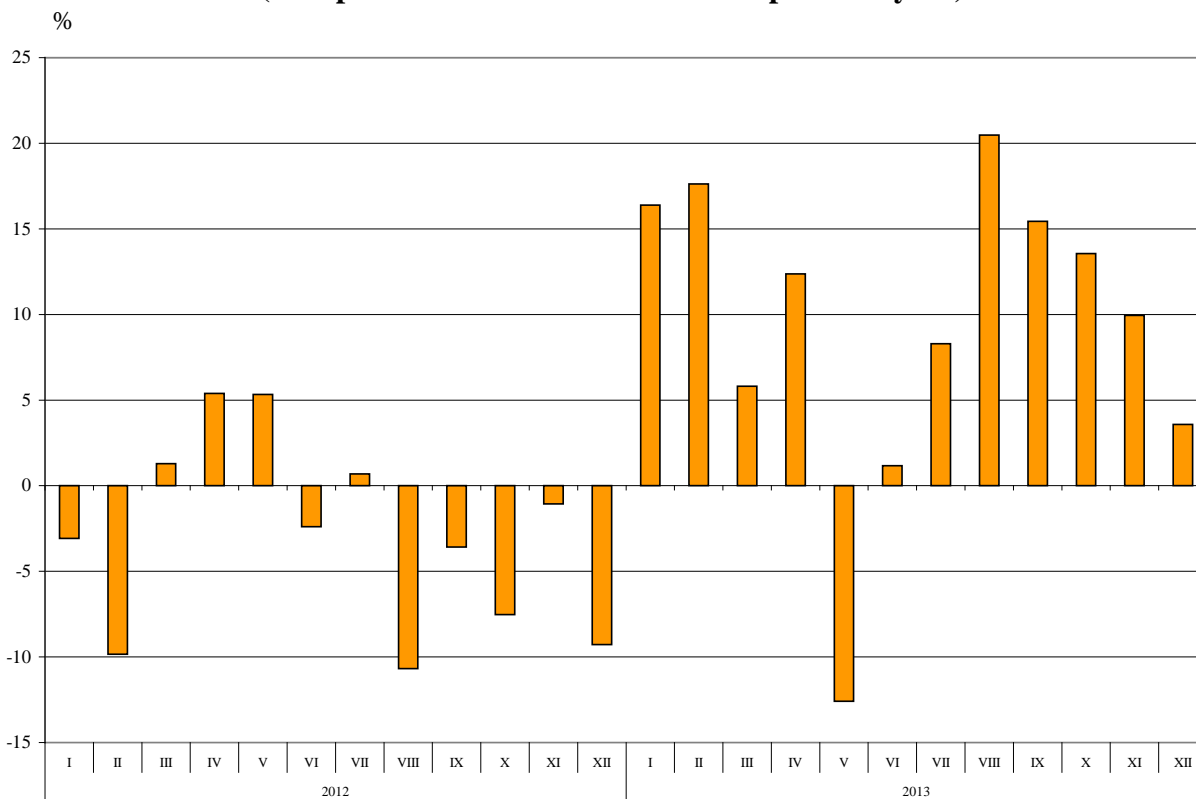

Bulgarian trade with EU

In 2013 the **exports** of Bulgaria to **EU countries** increased by 9.1% compared to the previous year and amounted to 26.1 Billion BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Germany, Italy, Romania, Greece, France, Belgium and Spain which accounted for 75.3% from the exports to EU (Annex, Table 3).

(Compared to the same month of the previous year)

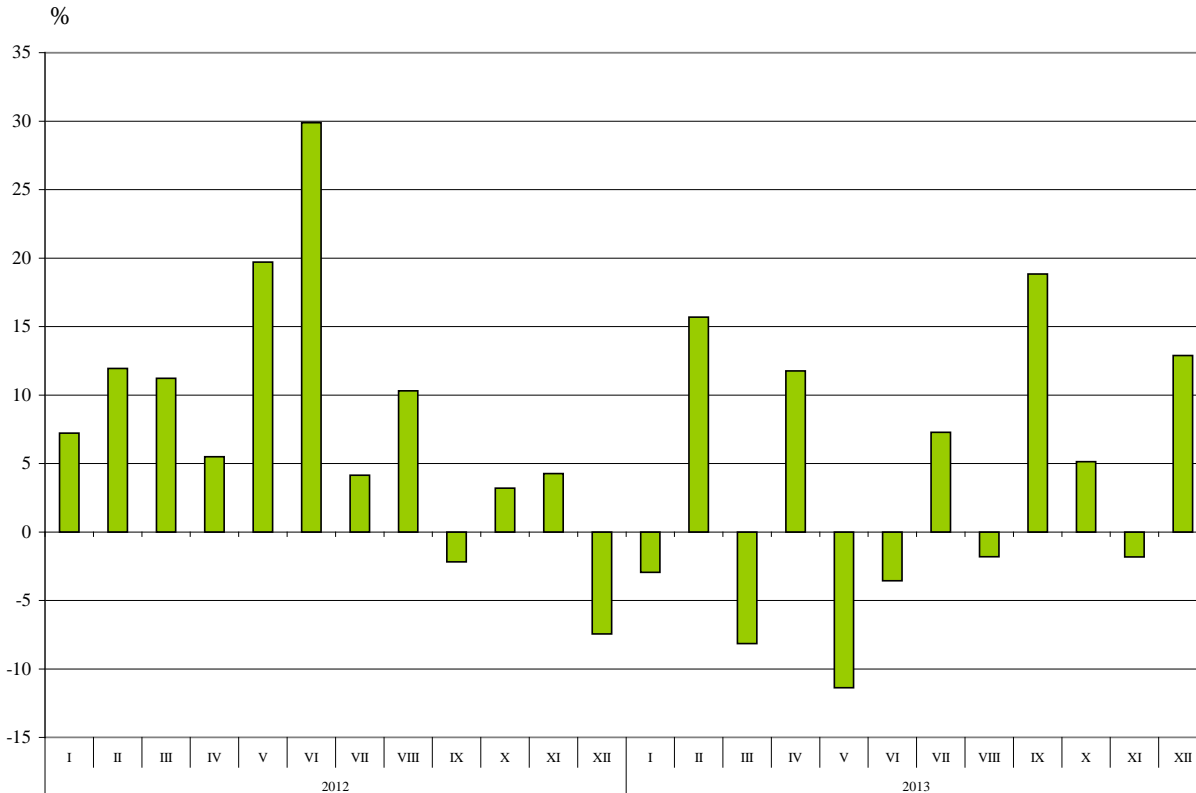


The Bulgarian **imports from EU countries** in 2013 increased by 3.1% compared to the previous year and added up to 30.2 Billion BGN (Annex, Table 1 and 2). The largest amounts were reported for the goods imported from Germany, Italy, Romania, Greece and Spain.

Foreign trade balance (exports FOB - import CIF) of Bulgaria with **EU countries** was negative and amounted to 4.1 Billion BGN in 2013 (Annex, Table 1).

The **exports** of Bulgaria to **EU** distributed according to the Standard International Trade Classification showed that in 2013 compared to 2012 the largest increase was observed in exports from the section „Animal and vegetable oils, fats and waxes” (by 29.5%) (Annex, Table 4).

The largest increase in **imports** from **EU** was observed in section „Beverages and tobacco” (by 8.7%).

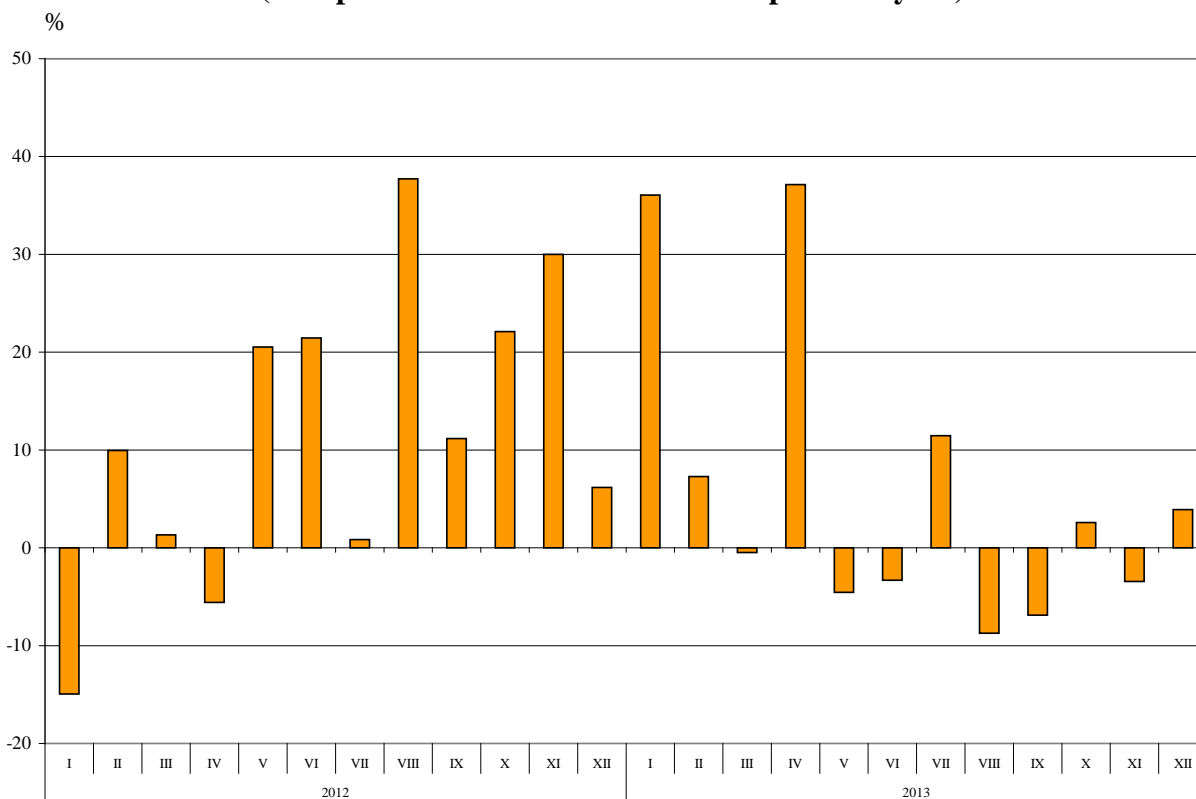

Bulgarian trade with third countries

In 2013 the Bulgarian **exports to third countries** increased by 4.5% compared to the previous year and added up to 17.4 Billion BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Turkey, China, Russian Federation, Ukraine, Gibraltar, Serbia and Former Yugoslav Republic of Macedonia which accounted for 53.7% of the total exports to non EU countries (Annex, Table.3).

(Compared to the same month of the previous year)**

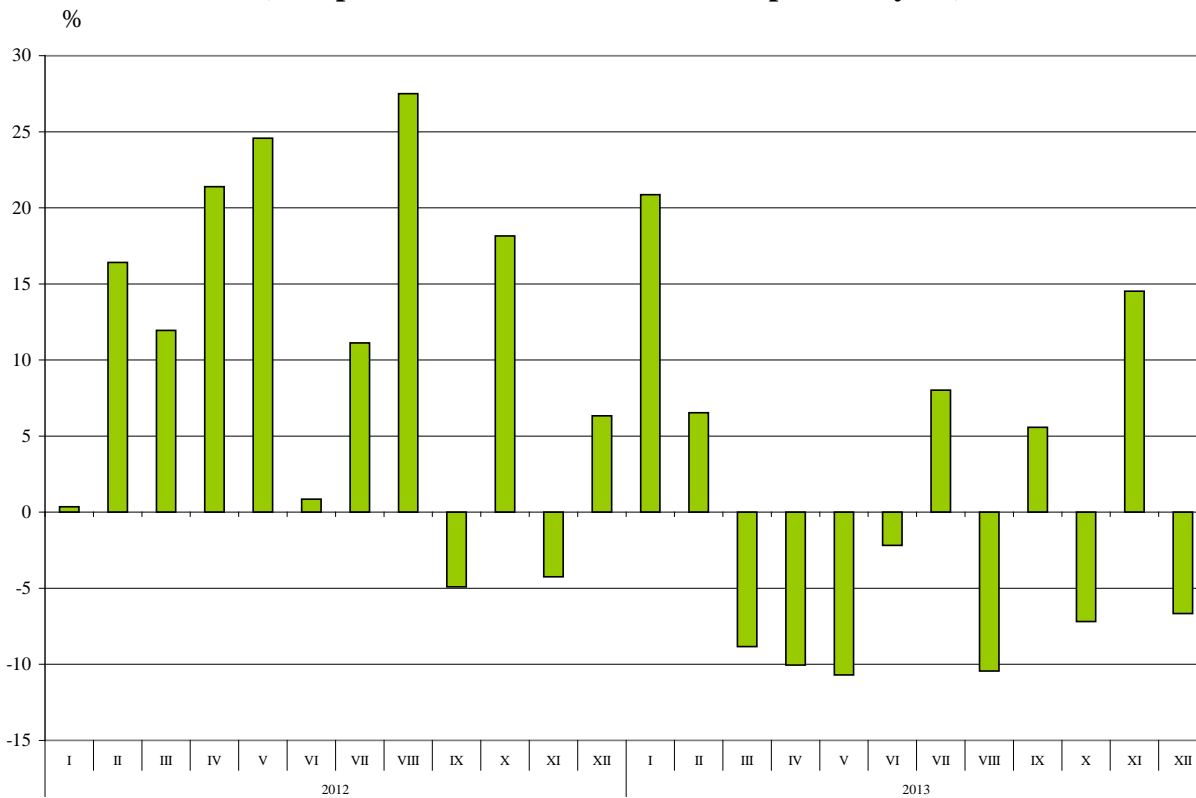


Bulgarian **imports from third countries** in 2013 decreased by 0.9%, compared to the previous year, and amounted to 20.4 Billion BGN (Annex, Table 1 and 2). The largest amounts were reported for the goods imported from Russian Federation, Turkey, China and Ukraine.
