ANNEXI

Since the beginning of 1997 National Statistical Institute of the Republic of Bulgaria has implemented National Classification of Economic Activities (NCEA), based on Statistical Classification of the Economic Activities in EC (NACE Rev.1). NCEA is elaborated in three hierarchical levels (division, group and class), each level is connected

respectively with NACE Rev.1 levels: division, group, class.

Statistical data are summarized by activity groupings by Nomenclature B16 or by Nomenclature V40 using and processing statistical data from survey units by NCEA-classes following the methodology recommended by EUROSTAT for defining the units activity code, on the basis of the annual surveys on receipts from sales of the main unit activity through the year. The groupings by sections and branches are not a hierarchical level of the national activity classification, for this reason they are not compatible with the categories of the Classification of Branches of National Economy (CBNE '86), used since 1986. In this case, they could not be used for keeping records and in computerized information systems.

Headings of the activity groupings in English of the Nomenclature B16 and Nomenclature V40 in accordance with their coverage are formulated by terms, used in NCEA Rev. 1 in English. Headings of the activity groupings in

Bulgarian reflect the national traditions.

In the publication is implementing the short headings of the economic activity groupings by NCEA nomenclature B16 and V40.
